#### **Responsibilities of the Executive Committee**

**Practitioner's Responsibilities**

Our responsibility is to form a conclusion on the attached income and expenditure account, based on our engagement, and to report our conclusion to you, as a body, and for no other purpose. We do not assume responsibility towards or accept liability to any other person for the contents of this report.

We conducted our engagement in accordance with Hong Kong Standard on Assurance Engagements 3000 (Revised) "Assurance Engagements Other Than Audits or Reviews of Historical Financial Information" and with reference to Practice Note 850 "Reporting on Flag Days and General Charitable Fund-raising Activities Covered by Public Subscription Permits issued by the Social Welfare Department" issued by the HKICPA. We have planned and performed our work to obtain limited assurance for giving our conclusion below.

The work undertaken in connection with this engagement is less in scope than an audit conducted in accordance with Hong Kong Standards on Auditing and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

Our engagement included carrying out limited procedures for obtaining sufficient appropriate evidence to be able to draw a conclusion, such as inquiries primarily of persons responsible for financial and accounting matters and other procedures we considered necessary. The procedures performed in a limited assurance engagement vary in nature and timing from, and are less in extent than for, a reasonable assurance engagement. Consequently, the level of assurance obtained in a limited assurance engagement is substantially lower than the assurance that would have been obtained had a reasonable assurance engagement been performed.

**Inherent Limitations**

Due to the nature of cash receipts and expenses relating to the Event, it was not practicable for us to determine whether the income and expenditure account and the books and records of the Permittee include all transactions relating to the Event. It was impracticable for us to quantify the potential impact of this on the income and expenditure account. Accordingly, our report relates solely to the income and expenditure account prepared from transactions that have been recorded in the Permittee's books and records.



**1. General Information**

The purpose of the general charitable fund-raising activity is to raise funds for suicide prevention services expenses of Suicide Prevention Services Limited.

**2. Summary of Significant Accounting Policies**

(a) Basis of preparation of the income and expenditure account

These income and expenditure account has been prepared under the accrual basis of accounting.

(b) Taxation

Suicide Prevention Services Limited is exempted from Hong Kong Profits Tax under section 88 of the Inland Revenue Ordinance.

(c) Income recognition

Proceeds from fund-raising activities are recognised on a cash basis.

**3. Proceeds from Donation Boxes**

Proceeds are from boxes placed at different locations (Park Central Shopping Arcade, HomeSquare, Uptown Plaza, New Town Plaza Phase III, Landmark North, Metroplaza) to invite public donations.
